Corporate disclosure of Greenhouse Gas (GHG) emissions has gained momentum over recent years due to a convergence of regulatory requirements, public pressure, and investor concerns over the impact of climate change-related risks on corporate performance. Most publicly listed companies already disclose Scopes 1 and 2 emissions on a regular basis, and attention is turning towards Scope 3 emissions disclosure. Up to 90% of a company's GHG emissions come from the supply base, which means that procurement has a great opportunity to step up and lead on climate change. Carbon Management provides the visibility to manage scope 3 GHG emissions and begin the path to carbon neutral and on towards Net Zero.

Carbon Management accesses approved data sources and aligns with the GHG Protocol and guidance to provide a view of your carbon footprint by category. As a part of the set-up, we tune the model to better reflect your specific context. The tool is particularly strong in the reporting of indirect categories of spend which are often the most difficult to assess. Carbon Management sits within a broader group of modules, including our very own Project Management which it utilises to manage all calibration, mitigation and offset projects. The resultant analysis can be delivered as a standalone solution or combined with Spend, Contract and Risk analytics and reporting for customers of our platform.
